**General Orders No. 10** 

2024-2025 Series

1. Attention is directed to Section 217 of the National Bylaws, Nomination, Election, Installation and Term of Office. Post officers shall be nominated, elected and installed as prescribed in Section 217 of the Manual of Procedure.

Manual of Procedure, Section 217, Nomination, Election, Installation and Term of Office:

**Nomination:** Nominations of Post Officers shall open in March and remain open until the Post is ready to vote, provided, however that when a poll system is used, as hereinafter described, nominations must be closed at the meeting prior to the election to allow the Adjutant to prepare a printed ballot.

**Election:** Post Officers shall be elected in April. Balloting for Post officers may be conducted by open vote or written secret ballot (handwritten or printed) at a regular Post meeting, or, if required by Post Bylaws or authorized by Post vote prior to the opening of nominations, by a poll system. Absentee ballots and proxy votes are prohibited.

2. Attention is directed to: National By-Laws, Sec 222, Delegates, District Convention & Meetings, Department and National Conventions: provides that (a) delegate strength shall be one for every thirty members or fraction thereof in good standing. (b) Delegates elected under this section shall not be considered instructed and may exercise full authority in the duty to be performed. (c) Each Post will pay, in accordance with its Department Bylaws, a delegate registration fee for each and every delegate to which the Post shall be entitled. (d) Each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified register delegate for the National Convention.

<u>Pursuant to MOP, Sec 222</u>, Delegates and alternates for the District Convention and Meetings, Department and National Conventions shall be elected a regular meeting in April. <u>Delegate strength will be based on members in good standing as of March 31st.</u> Delegate and alternates of each Post shall serve as delegates throughout the year provided, they remain members in good standing in the respective Post within the District.

- 3. <u>Eligibility for Officers:</u> All Posts, Districts and Departments should be reminded of the provisions of Sections 215, 415, and 515 of the Manual of Procedure that all members in good standing in a post shall be eligible to hold office given that, officers, elected and appointed, shall not be installed or assume the duties of their office until proof of eligibility has been submitted to the respective Adjutant and properly reviewed.
- 4. Commanders on all levels are reminded that according to Section 105 of the National Bylaws, a member whose dues are unpaid after their anniversary date ceases to be a member in good standing and loses all rights of membership in the Veterans of Foreign Wars. They shall not attend meetings or conventions and shall not participate in Post, County Council, District, Department or National functions.

Here is some news from Action Corp:

On April 1, the TRICARE Online Patient Portal will no longer be available. The Department of Defense's new electronic health record—MHS GENESIS—has replaced the TOL Patient Portal. As part of the transition, the DOD is decommissioning the TOL Patient Portal. If you want to keep a copy of your legacy health records for personal use, you must download them from the TOL Patient Portal before April 1.

"All military hospitals and clinics have transitioned to MHS GENESIS. We encourage you to take these important steps to save your personal health records before the TOL Patient Portal decommissions," said Rear Adm. Tracy Farrill, Principal Deputy, Assistant Director for Health

Care Administration, and Military Health System EHR Functional Champion at the Defense Health Agency. "Your medical history is a valuable resource for managing your health, and saving your records now ensures you have access if you need it."

Here's what you need to know before the TOL Patient Portal decommissions. Why is the TOL Patient Portal decommissioning?

The MHS GENESIS Patient Portal has replaced the TOL Patient Portal. As detailed in the TRICARE Choices in the United States Handbook, MHS GENESIS allows you to access your EHR 24/7. You can also book and cancel appointments, request prescription refills and renewals, see clinical notes and certain test results, and exchange secure messages with your military healthcare team.

The change from TOL to MHS GENESIS eliminates the need to maintain two systems and streamlines EHR management.

What will happen to my records?

• Provider access: Your provider will continue to have access to your complete health records.

• Personal access: You can use the steps below to download your legacy records for personal use before April 1. You can also request a physical copy from your military hospital or clinic's records management office. To do this, you'll need to complete a request form in person, and then return at a later designated time to pick up the records. Beginning April 1, if you want your legacy health records, you'll have to follow this process. What should I do now?

To keep copies of your legacy health records, follow these instructions:

1. Visit www.TRICAREOnline.com.

2. Log in: Sign in using your DS Logon, CAC, or DFAS myPay credentials. If you don't have a DS Logon, you'll need to create one by clicking "Need An Account."

3. Access: On the TOL homepage, click the blue "Health Record" button to view your personal health data.

4. Find data: Select "Download My Data." You'll see several data categories.

5. Customize: Choose the person, data types, date range, and format for the records you want to download.

6. Download: You can choose to download your records in portable document format (.pdf) or as a (.xml) continuity of care document. The CCD format allows you to share your data with family, caregivers, providers, and healthcare systems, or to document data in your preferred personal health record.

7. Save: After downloading, you can either open the file or save it securely for future use. You can also print your records and store them in a safe place.

Don't wait—take action.

Remember: The TOL Patient Portal will only be available until April 1. Take the time now to download and store your health records to ensure you can easily access them if needed.

VFW Claims Assistance for K2 Troops: Veterans with prior service in Uzbekistan at the Karshi Khanabad Air Base, known as K2, who need assistance with their VA disability claims

should contact a VFW Service Officer. The VFW is ready to assist K2 veterans who currently have health conditions they believe were caused by toxic exposures during their service. This includes veterans who have had VA claims denied, have claims in appeal, or who have never applied. Contact the VFW at vfw@vfw.org or find a VFW Service Officer in your area.

Report from the OKC VAMC Director: Director Vlosich: Provided an email update. Spoke on the Possible delay in email communications. They have seen an increase of 500 new veterans in the past three weeks, and in response to the continued increase in patients they are expanding primary care physicians at several of the clinics. Dermatology surgery is now being completed at the hospital. They are in talks with OU Medicine to get more doctors trained in dermatology. They will be starting an orthopedic express clinic soon. The Lawton clinic's expansion has been approved by the DOD. They hired another provider for the Enid Clinic and are in the process of hiring one for the Shawnee Clinic.

The Women's Clinic is scheduled to open soon. The mobile van is now being used to treat homeless veterans. Report from Jack C. Montgomery VAMC: Director Denning: Shane Glover provided an email update: The Tulsa hospital building is going great; the weather so far has not delayed construction.

Eagle Ops: Johnathon Shepard provided a handout. Spoke on OK Veterans Calendar, the OKC Vet Fest is scheduled for September 6.

FEDERAL ISSUES: Scott Ellis: The Honorable Douglas A. Collins was sworn in as the 12th secretary of the VA on February 5, shortly after the Senate confirmed him for the position by a vote of 77-23. Secretary Collins represented Georgia's rural Ninth Congressional District for nearly a decade before attempting an unsuccessful run for the Senate. He has served in the military since 2002 and is currently a colonel in the Air Force Reserve. In his message to veterans and VA employees, Secretary Collins pledged to take great care of America's veterans by first putting them at the center of everything VA does. He also promised to deliver timely access to care and benefits to those who are eligible to receive them, celebrate the vast majority of VA employees who do a great job every day, and hold employees accountable when they fall short of the mission. He pledged to also challenge the status quo in order to find new and better ways of helping VA beneficiaries.

STATE ISSUES: Chairman Peterson: Update on state legislation. The Senate Public Safety Committee approved Senate Bill 780, which creates a felony for any person found to have removed the United States flag on public or private property owned by another person or entity without permission and puts up the flag, standard, colors, or ensign of any other entity. "Our flag is not only a symbol of our great nation, but an embodiment of the sacrifices made by those who fought to protect the freedoms it represents," Jett said. "Senate Bill 780 ensures that the United States flag is protected from those aim to defile it by increasing the criminal punishment for such acts."

I want to start this with a request from Programs Director Lynn Rolf. If you are looking at the All-American Dashboard you will notice that your "Community Service" column is red, this is because we are in a new quarter. That column resets every quarter. If you click on the square, it will tell you what quarters have been reported. The community service reports are put in on the Department dashboard and then National will pull it over. If you have any questions on this or anything else please reach out to me.

**COMMANDERS & ADJUTANTS:** <u>Pursuant to MOP, Sec 222</u>, Delegates and alternates for the District Convention and Meetings, Department and National Conventions shall be elected a regular meeting in April. <u>Delegate strength will be based on members in good standing as of March 31st.</u> Comrades, on 31March 25, I will go into the Online Membership System (OMS) and obtain the members in good standing for each Post within our department. Shortly after, I will be publishing a delegate strength roster showing the number of delegates for each Post. This will be your delegate strength for all conventions at District, Department, and National Level. Included on the form will be the Department Delegate Dues owed by each Post. A delegate worksheet is also available with these General Orders. Delegate worksheets must be mailed, emailed, or turned into the Department registration table prior to convention voting.

#### Pursuant to VFW-Oklahoma Bylaws, Article 5,

**Section 2**, Delegates and alternates for the District Convention and Meetings, Department and National Conventions shall be elected at a regular meeting in April. Delegate strength will be based on members in good standing as of March 31st.

**Section 3,** A delegate registration fee established by the Council of Administration will be paid by each Post for every delegate to which it is entitled and by others authorized to cast a vote as defined by the national Bylaws. This fee may be increased/decreased at each succeeding convention by the Council of Administration. Said fees shall be paid to the State Quartermaster 15 days prior to the opening session of the Department Convention. Anyone wanting to register after this date will be assessed an additional fee of \$1.00 for each delegate registered. <u>Post</u> <u>delegate fees are due and payable regardless of convention attendance.</u> Posts that do not pay prior to the convention will be assessed the delegate fees at the plus \$1.00 rate.

In the links with these general orders, you will find the DEPARTMENT delegate worksheet. As stated above, your delegates should be elected at the same meeting in which you elect post officers. This worksheet should be filled out and sent back to me at <u>vfwhqokqm@outlook.com</u>, <u>vfwokadj@outlook.com</u>, or mailed to the Department at PO Box 1126, OKC, OK 73101. Please try to have these back to me before the State Convention so that the delegate badges can be prepared in advance.

Post Quartermasters should have received a packet from National Headquarters last month. This packet includes an election sheet and delegate worksheet for National. Election reports and National Delegate reports can be submitted through OMS.

As a reminder whether your Post attends the State Convention or National Convention or not the delegate dues are required to be paid. National dues are \$25 for the first delegate and an additional \$10 for each added delegate. The Department dues for each post can be found in the "Post Delegate Dues" link. These dues should be received by the Department by June 12<sup>th</sup>. Any dues not received by this date will incur an additional \$1.00 fee.

The 2025 Oklahoma State Convention will be held June 26-29, 2025, at the Embassy Suites – Norman Conference Center and Hotel. The official announcement and hotel room reservation information is included in the links. The agenda and banquet information is forthcoming.

Any Post that wishes to submit proposed bylaw changes <u>must</u> have them sent to the Department NO LATER THAN April 29, 2025, for advancement to the Bylaws Committee. The proposed bylaw changes that have already been submitted and reviewed by the committee are also included in the links for these General Orders along with the recommendations of the committee for each.

Member meetings are held the 2nd Tuesday of each month at 7:00 p.m. at the post location at 519 Main Street in Woodward with Post Commander Jack D. Day presiding. The Woodward post was recognized as a Diamond Jubilee unit in 2020 (75th anniversary). They are currently serving in their 80th year. Long-time member Curtis (Doc) Bohlman has served many times as the National Surgeon, greatly enhancing the post.

## Training and Development Randy Traxler and Jim Bassett

Call to Action

As leaders, we often face challenges that seem like people problems but are, in reality, process problems—or the lack of a process altogether. This concept aligns with the leadership framework **OIL: Observations, Insights, and Lessons Learned.** By focusing on what we see, what we learn, and how we apply it, we can strengthen our districts and posts.

For the April General Orders, I want to incorporate your perspectives by gathering real-world examples of leadership challenges and solutions. Below are a few key questions designed to capture your experiences. Please choose at least one to answer:

• **Observations:** What common challenges do your posts face in executing their programs or initiatives?

*Example:* A post may struggle to organize community service events due to inconsistent volunteer turnout. How have you addressed similar challenges in your district?

• **Insights:** Have you noticed any patterns in successful posts that others could learn from?

*Example: Some posts have seen increased participation by hosting family-friendly events or partnering with local businesses. What strategies have you seen work well?* 

• Lessons Learned: What is one leadership or operational lesson you've learned that could help other commanders improve post management?

*Example:* A commander implemented a structured mentorship program for new officers, leading to better continuity and leadership development. What lessons have you learned that others could apply?

• **Process vs. People:** Can you share an example where an issue initially seemed like a people problem but was actually a process issue? How was it resolved?

• **Communication & Engagement:** How do you ensure effective communication and engagement between district leadership and individual posts?

*Example:* A district improved engagement by using a structured email and social media strategy, ensuring timely updates and responses. What methods have helped you enhance communication?

• **Sustainability:** What strategies have worked for recruiting and retaining engaged members at the post level?

*Example: One post started a "buddy system" where longtime members personally welcome and check in on new recruits, leading to higher retention. What approaches have you found effective in keeping members involved?*

# EMAIL PHISHING Randy Traxler

Scammers are working harder than ever to steal personal information through phishing emails and text messages (smishing). As part of the **VFW Oklahoma** community, we want to ensure you stay informed and protected.

### How to Recognize and Handle Phishing Attempts

- If You Receive a Phishing Email:
  - Do NOT click on links or open attachments—they may contain malware.
  - Verify the sender—look for misspellings or unusual addresses.
  - Report the email:
    - Use your email provider's "Report phishing" option.
    - Forward it to **reportphishing@apwg.org** (Anti-Phishing Working Group).
    - If it appears to be from a trusted company, report it directly to them.
  - Mark as spam and delete the email.
  - Enable Two-Factor Authentication (2FA) on your accounts for added security.
- If You Receive a Phishing Text (Smishing):
  - **Do NOT click links or reply**—this confirms your number is active to scammers.
  - Report the text by forwarding it to 7726 (SPAM) and to the FTC at reportfraud.ftc.gov.
  - Block the sender on your phone.
  - **Check with the company directly** if the message claims to be from your bank, service provider, or another organization.
  - Keep your phone updated to protect against security threats.

### What to Do If You've Already Been a Victim

If you've clicked on a phishing link or shared sensitive information, take action immediately:

- Change your passwords for any affected accounts.
- Contact your bank or credit card company if you shared financial information.
- Report identity theft to the FTC at <u>www.identitytheft.gov</u>.
- Scan your devices for malware if you clicked on a suspicious link.

By staying vigilant, we can protect ourselves and each other from cyber threats. If you suspect a phishing attempt targeting VFW members, please report it immediately.
